January 30, 2018

A public business meeting of The State Horse Racing Commission was held at the following date, place and time: FARMSHOW Complex in the Susquehanna room in Harrisburg, PA, Tuesday, January 30, 2018 at 1:00 P.M.

IV. OLD BUSINESS

Marketing:

Ms. Eisenbeil spoke to the commission regarding the Pennsylvania Commission booth that was set up for the week at FARMSHOW. The booth had an education rack card, pencils, book marks, pens, stakeholder brochures along with Thoroughbred and Harness tack to show the public the difference between the two breeds. Ms. Eisenbeil and Mr. Klouser the Director of Enforcement did two 30 min kid friendly presentations. The kids got to dress up the jockey's silks and driver's colors. Parx Hall of Fame jockey Tony Black was a huge hit and was even given time on Facebook live.

Savvy Group has completed the online surveys and have now moved on to the focus groups. 900 plus participants have completed the online survey. The focus groups will occur in both eastern and western Pennsylvania.

V. INDUSTRY REPORTS

Mr. Steve Koch of the National Thoroughbred Racing Association, gave a presentation to the Commission regarding the process for becoming an NTRA accredited track and encouraged all Pennsylvania tracks to do so for the best interest in racing.

Alan Forman, Chairman, THA, spoke to the commission about the Mid Atlantic Thoroughbred Championships which are starting up again this year after few years off. There will be five races in each division running for purse money up to \$400,000 with all the tracks in the region participating including all three tracks in Pennsylvania.

Mr. Foreman also spoke about the Interstate Anti-Doping and Drug Testing Standards Compact.

Mr. Russell Williams, USTA, spoke about the Interstate Anti-Doping and Drug Testing Standards Compact from a Standardbred prospective.

Michael Ballezzi, Executive Director, PTHA, informed the commission that he met with Jim Gagliano and is working on putting the chips in all horses at Parx.

Todd Mostoller, Executive Director, PA HBPA, thanked the commission for the amended order on the thoroughbred helmets and vests issue.

Kim Hankins, Executive Director, MSOA, informed the commission that EVH-1 has broken out at the Meadows and racing is shut down until the end of February.

Jim Simpson, President, Hanover Shoe Farm, thanked the commission for getting out the Breeders awards early.

Brian Sanfratello, Executive Director of the PHBA, reported on the following PHBA activities.
