

# Invasive Aquatic Animals of Greatest Concern to Pennsylvania

## Threat Category:

- Potential: Not yet found in Pennsylvania, but considered a potential threat.
- Emerging: Has been detected in some locations, with risk of spreading.
- Established: Widely established in Pennsylvania.

**Score:** A composite score from 0-80 reflecting the potential invasiveness of a species and its economic, environmental, and human health impacts using a modified [Generic Impact Scoring System for invasive species](#). The scoring system was modified to include an assessment of invasive potential. Species without scores have yet to be evaluated.

\*Native to some parts of Pennsylvania.
