## March 29, 2018

A public business meeting of The State Horse Racing Commission was held at the following date, place and time: FARMSHOW Complex in the Susquehanna room in Harrisburg, PA, Thursday, March 29, 2018 at 1:00 P.M.

This research will be used to develop an effective statewide branding campaign for Pennsylvania's breeding and racing industry.

Through Ms. Eisenbeil, the Marketing Advisory committee recommended and sough a motion to approve a grant to the Pennsylvania Horse Racing Association (Equine Coalition) for \$825,000.00 to facilitate the creative branding development and media buys.
