Overview

Act 225 of 1982, as amended by Act 119 of 2008, charged the Pennsylvania Department of Agriculture with enforcing the commonwealth's Dog Law.

The Bureau of Dog Law Enforcement ("BDLE"), under the Pennsylvania Department of Agriculture ("Department"), enforces all Dog Law-related regulations, including licensing individual dogs, licensing and inspecting kennels, humanely capturing dogs found running at large and placing them in shelters, investigating dangerous dog incidents, enforcing safety measures for dogs deemed dangerous, investigating and prosecuting illegal kennel operations, and processing claims for livestock damage caused by dogs and coyotes.

As required by Section 906 of the Dog Law, this report to the General Assembly provides:

Dog Licenses

County treasurers and agents sell dog licenses to Pennsylvania residents. The current cost of an annual dog license is \$6.50 for altered dogs, \$8.50 for unaltered dogs and \$31.50 for a lifetime license is for altered dogs and \$51.50 for unaltered dogs. These fees are set in statute and have not been increased in over 24 years. Revenues from the sale of annual and lifetime licenses are directed to the Dog Law Restricted Account. In accordance with the Dog Law. Philadelphia County and the cities of Altoona, Erie, Harrisburg, Pittsburgh, and Scranton administer their own dog license sales, retain all income and information generated, and do not report dog licensing sales income to the Department (reference Appendix J for Section 1201 of the Dog Law, which addresses enforcement by independent political subdivisions). While this report does not include sales or revenue generated within those cities, it is important to note that the fees are significantly higher in these cities ranging from \$6 to \$40 for annual licenses and \$30 to \$175 for a life or a 12-year license. Without a statewide BDLE, more counties or municipalities would have to charge significantly higher fees to provide these services at the local level. Legislation in the House and Senate would increase the dog license fee to \$10 (annual license) and \$49 (lifetime) and is the only solution to ensure the Department can meet its statutory obligations and protect Pennsylvania's dogs.

There were 809,834 individual dog licenses sold in 2020, including 759,950 annual and 49,884 lifetime licenses, generating \$5,370,969 in revenue (Appendix C).

Dog license revenue decreased by 12.6 percent from calendar year 2019 in 2020. While COVID-19 played a role in the lower numbers, the Department was projected to go negative in 2020 before COVID-19. BDLE's poor financial state and insufficient staffing as a result of a lack of funding has had a crippling effect on license sales. Specifically, being severely short-staffed in Region 7 (Lancaster County and Montgomery County) has caused wardens from other parts of the state to be pulled in to ensure kennels and dangerous dogs get their minimum two required inspections annually. There was no additional staff or resources left to dedicate to canvassing efforts, community education and engagement, or follow-ups with those who have not renewed their dog licenses. BDLE is not operating at ideal capacity and that has made it impossible for BDLE to maintain status quo, let alone increase license sales and do things such as canvassing that work and are measurable efforts.

Lifetime licenses sold have increased by 66% since 2007, with a 13% decrease in lifetime license sales from 2019 to 2020. From 2007 to 2020, over 600,000 lifetime licenses have been sold.

Kennel Licenses

BDLE licensed 2,793 kennels in Pennsylvania in 2020, garnering \$511,780 in license fees directed to BDLE's restricted account (Appendix D).

Kennel license revenue increased by 5.1 percent and the total number of kennels increased another 1.5% from calendar year 2019. The kennels (in-state) requiring inspections continue to increase annually, yet there has been no fee increase to help accommodate staffing and resource shortages.

Out-of-State Dealers

In 2020, 142 out-of-state dealers were licensed, generating \$15,100 in revenue for the restricted account (Appendix E).

Dog Law Inspections

A total of 5,857 kennel inspections were completed in 2020 (Appendix F). This is a slight decrease of 0.3% compared to 2019.

It is alarming that less inspections occurred in 2020 although the numbers of licensed kennels increased in totality. This occurred due to several factors: loss of six weeks in the field in mid-March through early May due to the COVID-19 pandemic; the financial crisis of BDLE that has not been addressed by the legislature; unable to fill necessary vacancies in critical counties, such as Lancaster; being significantly short-staffed – recheck inspections for end of the year were postponed until January 2021 due to necessity to ensure all kennels receive the minimum 2 inspections; there were several kennels that did not receive 2 inspections due to COVID positives. This is a direct result of not passing the dog license fee increase legislation.

Enforcement Activities

BDLE refused and/or revoked two kennel licenses/applications in 2020, a 75% decrease from calendar year 2019.

Thirty-five citations were issued for operating a kennel without a license in 2020, a 26% decrease from calendar year 2019.

In 2020, BDLE collected \$27,925 through administrative actions (settlements and civil penalties) and \$86,555 in Dangerous Dog registration fees.

Citation Issuance

In 2020, BDLE issued 2,119 summary citations and 122 misdemeanor complaints for kennel and other Dog Law violations, including, but not limited to, failure to license, dogs running at large or abandoned, and dangerous dogs (Appendix H).

Since FY 1998-99, 75% of the fines and penalties revenue collected by BDLE has been diverted to the Judicial Computer System Fund. Of the approximately \$320,000 collected in fines and penalties each fiscal year only \$70,000 is retained in the Dog Law Fund.

In 2020, \$189,590 or 73% of the total fines and penalties collected by BDLE was transferred out of the Dog Law Restricted Account and deposited into the Judicial Computer System Account. Since 1998 a total of \$4,624,386 has been transferred out of the Dog Law fund in accordance with Act 64. This annual reduction of fines and penalties revenue is a contributing factor to the fund's solvency issues. Increasing revenue generated through fines and penalties collected have no positive impact on the Dog Law Fund. Since 2006, the average balance in the Judicial Computer System Fund has been \$118 million while the Dog Law Fund has averaged \$5.4 million and is now requiring support from the Departments General Fund. Filing more citations will not resolve BDLE's insolvency.

Citations decreased by 21% compared to calendar year 2019. This decrease can be attributed to the COVID-19 pandemic, less staffing, and resources available. The priority was ensuring all kennels and dangerous dogs received inspections. There was not enough manpower and resources left to dedicate to efforts such as canvassing, illegal kennel investigations, and other services BDLE provides to keep communities safe.

Dogs Seized and Impounded and Total Reimbursements

BDLE plays a critical role in managing stray dogs by assisting with the humane capture and transport of dogs to shelters. Shelters and municipalities receive payments to help cover the costs associated with transporting, feeding, and caring for stray dogs. BDLE paid \$81,800 for 2,045 dogs statewide (Appendix I).

Dog Law Restricted Account – Revenue and Expenditures

All activities of BDLE are funded by a restricted account; all revenue and expenses related to BDLE are credited and disbursed from the Dog Law Restricted Account, as required by Section 1001 of the Dog Law.

In 2020, \$189,590 or 73% of the total fines and penalties collected by BDLE was transferred out of the Dog Law Restricted Account and into the Judicial Computer System Account. Since 1998 a total of \$4,624,386 has been transferred out of the Dog Law fund in accordance to Act 64. This annual reduction of fines and penalties revenue is a contributing factor to the fund's solvency issues.

To prevent the Dog Law Restricted Fund from going negative in 2020 \$1,283,000 in Personnel Costs were transferred to the State's General Fund. Actual personnel costs in 2020 totaled \$5.360.841.

Licensing Fees

The primary source of revenue for the Dog Law Restricted Account is the sale of individual dog licenses. This is supplemented by kennel licenses and fines that are capped at approximately \$70,000 annually. Individual dog license sales generated approximately \$5,370,969 in 2020.




The focus of BDLE in 2020 was to restore the solvency of the Dog Law Restricted Account. Unfortunately, without the passage of critical legislation to minimally increase dog license fees and lower the age for licensing dogs which would increase compliance, the BDLE struggled to meet bare minimum statutory requirements.

Since its enactment in 1893, the enforcement of the dog law has been funded through the sale of dog licenses. Dog licensing was created to hold individual dog owners responsible for damages when their dogs got loose and attacked farmers' livestock. The revenue raised from dog license dollars also provided reimbursement to farmers whose livestock was attacked by coyotes.

Now, as a result of the inaction to minimally raise the dog license fee, BDLE will be supported by general taxpayer dollars.



BDLE now relies on a transfer of taxpayer dollars in order to maintain the current level of statutory obligations. Even with taxpayer dollars, BDLE cannot fill critical vacancies, such as Lancaster or Montgomery counties, it only allows BDLE to continue operating at **status quo**.



From Lancaster to Philadelphia, there are an estimated 1.1 million dogs. With 1,000 licensed kennels that need inspected a minimum of twice annually, Region 7 has the heaviest workload for dog wardens in the commonwealth.

Lancaster County alone has more than double the number of licensed kennels than any other county in the state. The region has more than 140 registered dangerous dogs to monitor. And, just last year in 2020, there were more than 700 dogrelated incidents to respond to from the public. But as a result of the funding shortfall, both Lancaster and Montgomery County are without a dedicated dog warden.

Anyone in these counties who loses their dog, gets attacked by a vicious dangerous dog, or just wants the dogs living in the 1,000 breeding operations here to be well cared for is affected by the lack of a dog license fee increase.

Status quo is not enough. So much has changed and evolved since 1983 and the Dog Law is no exception. There are more residents and more dogs. With the increase in population and number of dog owners comes an increase in dog-related incidents and more kennels to fill supply and demand.

The COVID-19 pandemic has shown that people rely on dogs for companionship. While many industries were negatively impacted, the dog breeding and adoption industries created an even larger supply shortage. As Pennsylvania continues to recover from the COVID-19 pandemic and get back to work, we anticipate an increase in dog-related incidents. Due to social distancing and limiting gatherings, BDLE saw a decrease in dog incidents – related to dogs running at large, dog bites, and lost dogs – in 2020.

While the dog license fee has remained the same for 24 years, BDLE's operational costs continue to climb and have led to today's current deficit. Since 1996, personnel costs have nearly doubled, with an increase of 88%, despite reduced staffing levels and not filling mission critical vacancies. Operating costs have more than doubled, increasing by 172%. There is a clear discrepancy regarding BDLE's primary revenue stream (dog licenses) and the increased costs associated with fulfilling BDLE's statutory requirements.

Since 1996, priorities for BDLE have changed. With licensed kennels increasing in numbers by 20% and some of the strictest kennel standards in the nation as of 2008, BDLE spends more time and resources to keep Pennsylvania's nearly 3,000 breeding operations up to par for the dogs who spend their lives there. Since 1996, the total number of kennel inspections has increased by 85%.

While BDLE is clearly doing more with less, it is only a matter of time until the good work of the past years slips away. Pennsylvania will reclaim its title as Puppy Mill Capitol of the East, there will be more outbreaks of infectious and contagious diseases for both dogs and people, and more people become victims of a dangerous dog attacks due to lack of monitoring.



Grim Outlook

Without a fee increase, taxpayer support will continue to be necessary to allow for BDLE to continue protecting the safety and welfare of dogs in the commonwealth, as well as human health as it relates to dog attacks and containing infectious and contagious diseases. The loss of BDLE and the services provided is the most immediate threat to the welfare of dogs in Pennsylvania.

Who would be impacted by the loss of BDLE?

Local Government & Law Enforcement: Counties or municipalities will face an impossible decision: raise revenue to cover these vital services, which will likely cost more to the taxpayer to administer duplicative programs than a statewide program, or even worse, to not provide the services at all.

The burden of stray dogs, increased cruelty referrals, more frequent infectious and contagious disease outbreaks, and increased dog bite incidents will unfairly fall on law enforcement, continually asked to do more with less.



Dogs Living in Breeding Operations: As the only agency in the state that can inspect state licensed kennels without a search warrant, BDLE has a vital responsibility and duty to ensure the safety and welfare of dogs in kennels.

Often, when you hear about dogs being seized from a kennel, it was due to a dog warden making a cruelty referral to a humane society police officer or police officer after a routine inspection or investigating a complaint.

Kennel inspections provide an opportunity for wardens to ensure proper living conditions and check on the overall well-being of the dogs that live there. All wardens receive humane society police officer training in order to arm them with the knowledge they need to make quality cruelty referrals when necessary.

Dog wardens ensure kennel owners are held accountable for maintaining adequate living conditions for the dogs and puppies and strive to ensure Pennsylvania's dog breeding industry maintains high standards of care and continue to improve the image of the dog breeding industry.

- As a small business, kennel operators rely on quality inspections and reports to show consumers their kennel is a good place to buy a puppy or adopt a dog.
- When you read the headlines in the news about dogs being seized for poor health and horrific living conditions, oftentimes, it is from an illegal kennel operation.
- Illegal kennels or underground kennel operations are not regulated; these are the places
 most notoriously known as "puppy mills" where sickly dogs are bred and sold
 unbeknownst to the public.

Pennsylvanians at Large: From tracking and monitoring all of the dangerous dogs in the state, to investigating dog bites to bring justice to victims, and ensuring new puppy owners do not experience the heartache of a sudden death or lifelong health problems related to improper breeding or veterinary care of the dog, Pennsylvania's dog wardens work every day to protect Pennsylvanians and their furry best friends.

Strays – Dog wardens pick up and transport stray dogs to shelters. Shelters receive money from BDLE for taking in and holding stray dogs. Prior to 2021, shelters were eligible to be reimbursed \$40 for holding a stray dog placed by BDLE. Now, due to insufficient funds, this reimbursement has been lowered from \$40 to \$5, the minimum required by statute. This decrease in reimbursement is going to make it difficult to find shelters willing to hold strays, an impact that will affect everyone.

Dangerous Dogs – BDLE is solely responsible for the maintenance of a statewide dangerous dog registry. Any dog that attacks a person or pet and is deemed dangerous in court requires follow-up and registration for the remainder of the dog's life. This is one of the most important duties of BDLE as it relates to public safety for everyone who resides in the commonwealth or travels through the state.

Although police can handle an initial dangerous dog case, it is the dog warden who follows-up with registration, subsequent annual inspections, and updates to the data in the registry viewable by the public.

The personnel and resources required to follow-up and maintain an accurate statewide registry for dangerous dogs would be costly for counties and local law enforcement to implement.

In fact, in the few counties or municipalities that do administer components of the Dog Law at the local level, the cost of a dog license can be up to \$35 per year, compared to \$10 as proposed in the license fee legislation.

For years the Department of Agriculture has been asking for a minimal dog license fee increase to keep BDLE funded to continue its vital work noted throughout this report. But that warning has not been heeded.

Appendix J – Section 1201 of the Dog Law Addressing Enforcement by Independent Political Subdivisions

ARTICLE XII
MISCELLANEOUS PROVISIONS

Section 1201. Applicability to cities of the first class, second class, second class A and third class.

(a) Cities of the first class, second class and second class

A.— Insofar as this act provides for the individual licensing of dogs and the payment of damages for domestic animals injured by dogs or for licensed dogs illegally killed, it shall not apply to cities of the first class, second class and second class A. Such individual dog licensing and payment of damages in cities of the first class, second class and second class A shall continue to be carried on under the provisions of existing laws.

- (b) Cities of the third class Insofar as this act provides for the individual licensing of dogs by the department, the payment of damages by the department for domestic animals injured by dogs or for licensed dogs illegally killed and for the performance of duties and functions of dog law enforcement by the department under Articles I and II, except sections 206, 207, 209, 211 and 218 as it pertains to kennel inspections; Article III, except section 301; Articles V through IX; this article; Articles XI and XII, the foregoing responsibilities shall not apply to the department within a city of the third class that does both of the following:
- (1) Adopts its own dog licensing ordinance establishing individual dog licensure on a calendar year basis or on another basis consistent with that in use by the department.
- (2) Notifies the secretary, in writing, of its intention to assume responsibility for enforcement of its dog licensing ordinance under authority of this section for a period commencing January 1 of a particular year, and not ending prior to December 31 of the year in which the city of the third class terminates its responsibility for enforcement. If the department changes dog licensure from calendar year basis to some other basis by regulation promulgated under authority of section 201, it may modify the requirement set forth in this paragraph to provide for the efficient and equitable transfer of dog law enforcement responsibility and appropriate dog license fees from the city of the third class to the department.
