July 26, 2017

A public business meeting of The State Horse Racing Commission was held at the following date, place and time: FARMSHOW Complex in the Susquehanna room in Harrisburg, PA, Wednesday, July 26, 2017 at 1:00 P.M.

Commissioners in attendance were: Thomas Jay Ellis, C. Edward Rogers, Michele C. Ruddy, Darryl Breniser, Russell Jones, Salvatore DeBunda, Dr. John Egloff, Robert Lark, Dr. Corinne Sweeny by phone and Chairman Russell Redding. Also present were Commission legal counsel Brook Duer and Jorge Augusto.

The Chair called the meeting to order. Legal counsel noted that the meeting has been advertised in accordance with the Sunshine Law. Legal counsel noted that executive session was conducted at 12:00 p.m. for discussion of the following topics: Personnel matters; attorney-client privileged communication; litigation; commission adjudications.

Michael Lerman: Non-Disqualification of "Big Savor" (8th Race—Jan 31, 2017 at Parx Racetrack).

The Board of Stewards decision dated January 31, 2017 is AFFIRMED by the commission.

Motion by: Commissioner Ellis Second by: Commissioner Rogers

Passed: Approved by the Commissioners with an opposition by Commissioner Jones and two abstentions from Commissioner Lark and Commissioner Sweeney along with Commissioner DeBunda who recused himself, that the decision by the Board of Stewards not to disqualify the horse "Big Savor" from the 8th race at Philadelphia Parx on January 31, 2017, is AFFIRMED.

Wayne Rice: Non-Disqualification of "High Pitch" (3rd Race—September 15, 2016 at Presque Isle Downs).

The Board of Stewards decision dated September 15, 2016 is AFFIRMED by the commission.

Passed: Approved by the Commissioners with two abstentions from Commissioner Lark and Commissioner Sweeney that the decision by the Board of Stewards not to disqualify the horse, "High Pitch," from the 3rd race on September 15, 2016 at Presque Isle Downs racetrack is AFFIRMED.

Timothy Twaddle: Appeal of Ruling No. 16138M

Sam Beegle, President, PHHA, spoke for the Standardbred Industry stakeholders requesting that they would like all commission meetings to be held in Harrisburg, PA, also the fairs have been going very well for the 2017 season.

Todd Mostoller, Executive Director, PA HBPA, also agreed with the Standardbred stakeholders that the commission meetings should be held in Harrisburg, PA, and had some serious concerns about the Judges/Stewards list that was passed by the commission earlier today.

Joe Thomson, Winbak Farms, addressed the commissioners with how to get more out of state buyers to come into Pennsylvania to help with the breeding industry.
