WELCOMING DEAN AND JEREMY

Chair Gantz welcomed new Board members Dean Spencer and Jeremy Zeager, who introduced themselves for the record. Each provided their locations and information regarding their peach and nectarine crops.

FIELD WATCH

Emily Weaver, researcher, Penn State University, offered a PowerPoint presentation with regard to Field Watch, a company that promotes communication, cooperation, and collaboration in conjunction with the PA Department of Agriculture. She discussed the three voluntary mapping tools, including DriftWatch, BeeCheck and CropCheck. Ms. Weaver indicated the program was developed at Purdue University in Indiana in response to pesticide drift issues that had been occurring across the U.S., particularly where there was a lot of large scale conventional farming. REGIONAL ON-FARM TRIALS WITH CONTROLLER & KRYMSK86 ROOTSTOCK COVID-19 UPDATE

Dr. James Schupp, scientist with Penn State University located at the Fruit Research and Extension Center in Biglerville, PA, updated the Board with regard to a peach rootstock trial initiated with funds from the Peach and Nectarine Program in 2020. He noted the four rootstocks include controller 6, 7, 8 and Krymsk 86 developed at the University of California, Davis, and distributed to 10 farms within the Commonwealth. He stated the group worked with

containerized trees, and ended up short on controllers 7 and 8 and long on Krymsk 86 and Controller 6. Dr. Schupp indicated two of the growers, who originally signed up for the trial, dropped out. One only wanted a half planting. Two were contacted from the waiting list and two were recruited by PSU Extension Educators.

Dr. Schupp indicated the trial had a rough start. He discussed some of the challenges dealt with, including over five days in the back of a tractor trailer from California losing the original leaves but surviving. He thanked all who helped get the trees quickly distributed. Dr. Schupp answered questions from Board members.

MANAGEMENT OF PEACH BACTERIAL SPOT-YEAR 2 COVID-19 UPDATE

Ms. Riley stated Dr. Norman LaLancette sent an email indicating that he would not be present at today's meeting as there had not been any updates or changes to report due to the pandemic.

NEW BUSINESS

Mr. Andrews noted the new contract containing the auditing services would be sent to the Board, and the contract for those services would have to be addressed at the next meeting.

The next meeting is tentatively scheduled for Wednesday February 3, 2021 at 7:00.

Chair Gantz clarified that Board member Dean Spencer's farm is located in Berks County and not Somerset County. Some Board members discussed the price each is charging for boxes of peaches.
