#### **Section I: Performance Requirements**

#### 1.01 Purpose

This Invitation For Bid (IFB) is issued by the Commonwealth of Pennsylvania, Department of Agriculture, hereinafter referred to as PDA, to select a commercial food distributor, hereinafter referred to as DISTRIBUTOR, to receive, store, and deliver to eligible recipient agencies, hereinafter referred to as RAs, various food items, hereinafter referred to as COMMODITY, provided to PDA by the United States Department of Agriculture (USDA). Unless the context indicates otherwise, whenever the word "COMMODITY" is used herein, it shall be understood to include both.

A commercial food distributor is defined as an entity currently receiving, storing, and delivering food product on a regularly scheduled basis with adequate facilities and equipment to receive, store and deliver, as required by the IFB, additional volumes of groceries, frozen food, and chilled items. The Pennsylvania Secretary of Agriculture has sole discretion to determine if entities submitting bids meet the definition of a commercial food distributor for the requirements of this IFB. Each successful DISTRIBUTOR will enter into an Agreement with PDA.

#### 1.02 Regions

Geographic areas covered by the IFB are identified as Agriculture Distribution Regions (ADRs). Bids submitted in response to the IFB must be submitted by ADR. DISTRIBUTOR may bid on more than one ADR; however, separate bids must be submitted for each ADR. Attachment "A" shows counties by ADR.

#### 1.03 Realignment of ADRs

PDA reserves the right to realign ADRs by county, in whole or in part; by RA; or by type of RA if PDA determines the realignment to be in its best interests. PDA will seek the advice of the affected distributor(s).

If any DISTRIBUTOR terminates its Agreement with PDA for this IFB or is terminated by PDA prior to the scheduled termination date in Section 2.05 of this IFB, PDA may realign the affected ADR and add all or part of the affected ADR(s) served by the DISTRIBUTOR to another DISTRIBUTOR(s) under Agreement with PDA for this IFB, but only with the consent of the affected DISTRIBUTOR(s).

When DISTRIBUTOR consents and accepts the additional responsibility for all or part of an ADR(s) forfeited by another DISTRIBUTOR, PDA may authorize the DISTRIBUTOR accepting the new ADR(s) in total or in part, to charge for the new area of service, FEEs which shall be no more than five percent (5%) higher than the highest FEEs charged in the accepting DISTRIBUTOR's original service area(s) or the current FEEs of the ADR (or partial ADR thereof) being accepted, whichever is greater.

#### 1.04 Volume

The volume (number of total cases) of COMMODITY affected by the IFB are not guaranteed. However, the volume of COMMODITY <u>distributed</u> by ADR for the years ending June 30, 2019 and June 30, 2020 are provided on Attachment "B" for information purposes only.

#### 1.05 Estimates

DISTRIBUTOR shall understand that case volume and the number of agencies served are estimates and are subject to change. Annual volumes of COMMODITY under the IFB should approximate volumes listed on Attachment "B"; however, because USDA controls the total volume of product available to Pennsylvania, actual volumes are not guaranteed by PDA. An Agreement executed as a result of the IFB will not obligate PDA to specific quantities of COMMODITY, nor will PDA be obligated to a minimum or maximum number of RAs authorized to receive COMMODITY.

#### 1.06 COMMODITY Variety

PDA estimates that eighty eight (88) different COMMODITY items will be available annually under the IFB with an average of fifty (50) items carried in inventory at any one time.

## *Note: DISTRIBUTOR is cautioned that inventory turns for COMMODITY is highly dependent on the DISTRIBUTOR's effectiveness in informing RAs of cases of product allocated, pulled, and remaining in storage at the DISTRIBUTOR's facility.*

The mix of COMMODITY for the National School Lunch Program (NSLP) and Traditional Program for the 2019-2020 year was <u>50% frozen</u>; <u>5% chilled</u>; and <u>45% dry</u>.

The mix for COMMODITY received under The Emergency Food Assistance Program (TEFAP) for 2019-2020 was 5% frozen, 93% dry and 2% chilled.

Attachment "D" shows the current variety of COMMODITY available; however, no limit on variety is guaranteed. No guarantee is made by PDA of the actual number of different items.

An average case of COMMODITY weighs 40 pounds and measures 1.1 cubic feet.

#### 1.07 Recipient Agencies (RAs)

A list of RAs by ADR and volumes of COMMODITY received for the years ending June 30, 2019 and June 30, 2020 are listed on Attachment "C". The number of RAs eligible to receive COMMODITY is subject to change at any time by PDA.

RAs include, but are not limited to, schools participating in the NSLP, day care facilities, and summer feeding agencies; TRADITIONAL recipient agencies such as institutions, and agencies eligible under TEFAP such as food banks, food pantries, and emergency feeding entities such as soup kitchens and homeless shelters.

#### 1.08 Recipient Agency (RA) Classification

Eligibility for RAs to receive COMMODITY is determined by USDA and varies by USDA program. Therefore, for purposes of defining minimum orders, delivery frequency, and calculating bid prices under the IFB, RAs will be classified by PDA as either: 1) NSLP RAs; 2) TRADITIONAL RAs/Charitable Institutions; or 3) TEFAP RAs.

Approximately 60% of the total volume of COMMODITY to be distributed under the IFB will be to NSLP RAs; with the balance distributed to TRADITIONAL and TEFAP RAs.

PDA reserves the right to realign RAs without regard to ADR to improve efficiency. DISTRIBUTORS may, however, request of PDA a realignment of RAs by ADR to improve efficiency but realignment decisions rest solely with PDA.

#### 1.09 COMMODITY Codes

PDA will assign to each COMMODITY, prior to or on arrival, a numeric code that DISTRIBUTOR <u>shall</u> use with the COMMODITY description to track and report inventory and other activity. (See Attachment "D").

#### 1.10 Inventory Levels

PDA attempts to maintain, on average, a six to eight week supply of COMMODITY received for NSLP and TRADITIONAL RAs; and an eight (8) to twelve week (12) supply of COMMODITY received for TEFAP RAs. However, inventory levels may surge beyond anticipated levels. DISTRIBUTOR shall work with PDA to project COMMODITY usage and inventory levels.

Note: DISTRIBUTOR is cautioned that inventory turns for COMMODITY is highly dependent on the DISTRIBUTOR's effectiveness in informing RAs of cases of product allocated, pulled, and remaining in storage at the DISTRIBUTOR's facility. DISTRIBUTORs are encouraged to develop and maintain an efficient and effective line of communication for advising RAs of the availability of COMMODITY.

#### 1.11 Inbound Shipments of COMMODITY

Inbound shipments of COMMODITY are usually scheduled by USDA at predictable shipping periods; therefore, PDA will advise DISTRIBUTOR of the types and quantity of COMMODITY to be received.

Inbound shipments normally arrive one item per load (850 – 2,000 cases more or less) in full truckloads or in full or partial railcar loads.

PDA requests USDA to schedule inbound shipments to arrive by truck. However, DISTRIBUTOR must plan on some shipments to arrive by rail or piggyback. Shipments by rail will arrive at DISTRIBUTOR's warehouse or a nearby railroad siding designated by DISTRIBUTOR.

DISTRIBUTOR must accept all shipments regardless of shipping and/or loading methods. No shipments can be refused if loading and/or shipping methods are approved or considered acceptable by PDA.

When shipments are made by piggyback at the discretion of the USDA, DISTRIBUTOR must unload the "pig" in the allotted time or pay a fee for holdover. DISTRIBUTOR may request the "pig" company to upgrade the service so that "pig" personnel will unload the affected shipment. Service upgrades will be at DISTRIBUTOR's expense.

PDA requests shipments be palletized or slip sheeted, however, compliance is not guaranteed, either by USDA or PDA. Rail and piggyback shipments must be unloaded at DISTRIBUTOR's expense. Any adjustments of inbound shipments, particularly with regard to pallet sizes, stacking ties and heights, made for DISTRIBUTOR's convenience will be at DISTRIBUTOR's expense.

PDA will, however, pay DISTRIBUTOR \$80 for each inbound full trailer shipment of COMMODITY received which is not palletized. For railcars received "floor loaded" or "slip sheeted" payments will be prorated using standard truck sizes for COMMODITY received. For example, the standard truck size for COMMODITY 100208 Applesauce is 912 cases. A railcar of flour equals three truckloads, or 2,736 cases; therefore, payment under this provision for a railcar of 100208 Applesauce received floor loaded or slip-sheeted would be \$240, or three (3) times the single truck rate. Payments under this paragraph are subject to availability of federal funds; therefore, PDA may cancel this provision upon sixty (60) days written notice to DISTRIBUTOR.

DISTRIBUTORs wishing to contact suppliers (shipper) concerning dates of shipments or loading methods can obtain names of suppliers from PDA. Arrangements made with suppliers by DISTRIBUTOR for palletizing or slip sheeting will be at DISTRIBUTOR's expense. However, with truck shipments, truck drivers are required to tailgate products and call for unloading appointment 24 hours in advance.

#### 1.12 Receiving Appointments

Truck drivers are required to call DISTRIBUTOR for unloading appointments <u>at least 24</u> <u>hours in advance</u>. (It is the experience of PDA that truck drivers call for appointments in advance of minimum requirements).

When truck drivers call as required and request appointments, DISTRIBUTOR must provide appointments and accept delivery within 24 hours of requests if the 24-hour period falls on a normal workday and within DISTRIBUTOR's receiving hours as registered with PDA. DISTRIBUTOR shall provide PDA with receiving hours, and update with PDA when changed. When changes in receiving hours are not provided to PDA prior to commodity being ordered by PDA, the DISTRIBUTOR must accept deliveries with the hours listed with PDA. If the 24-hour period falls beyond DISTRIBUTOR's registered receiving hours, appointments must be given and delivery accepted on the next business day within the first hour of the registered receiving hours.

When truck driver fails to call as required and arrive without appointments at DISTRIBUTOR's facility, DISTRIBUTOR is not obligated to accept delivery at that time but must provide an appointment and accept delivery within 24 hours. If the 24-hour period falls beyond DISTRIBUTOR's registered receiving hours, an appointment must be given and delivery accepted on the next business day within the first hour of the registered receiving hours.

#### 1.13 Receiving Procedures

DISTRIBUTOR is responsible for COMMODITY received and must exercise the same care when receiving COMMODITY as for its own products.

DISTRIBUTOR shall inspect inbound COMMODITY shipments on arrival for condition, temperature, damage and infestation, and verify accuracy of count and COMMODITY acceptability; and shall call PDA immediately for instructions when the condition of a shipment is in question.

DISTRIBUTOR must accept all shipments which are shipped in accordance with USDA and/or PDA instructions or acceptance guidelines.

DISTRIBUTOR must accept all COMMODITY shipped by USDA; no product can be refused due to lack of warehouse capacity.

If COMMODITY is damaged or otherwise unacceptable, DISTRIBUTOR shall notify the truck driver or railroad and execute FNS Form 57 and forward immediately to PDA along with a copy of the Bill of Lading and other related papers required by PDA.

DISTRIBUTOR shall notify PDA promptly by telephone for disposition of damaged or short product.

DISTRIBUTOR must receipt the load received in WBSCM within <u>2 calendar days of receipt</u> (Note: USDA requires this be done in 2 calendar days, not business days).

DISTRIBUTOR shall forward to PDA in no less than 2 days a copy of the Bill of Lading and other related documents.

DISTRIBUTOR shall recoup damaged COMMODITY, whether damaged when received or during the storage and handling by DISTRIBUTOR, and ensure that all food safe for human consumption is salvaged for program use. Values of damaged COMMODITY and values of COMMODITY salvaged and released to RAs shall be tracked on DISTRIBUTOR records reported to PDA.

DISTRIBUTOR is responsible for the following:

- Paying all freight demurrage and detention charges resulting from DISTRIBUTOR's failure to accept delivery as required.
- Bracing or leveling shipments for further movement and removing debris from railcars.
- Having sufficient warehouse space to absorb all inbound freight at abnormal peak loads at no additional cost to PDA or RAs.
- Rotating stock on a first-in, first-out (FIFO) basis and maintaining evidence of stock rotation for review by PDA.
- Claims levied by USDA or PDA for failure to properly secure, handle, protect, or account for COMMODITY received by it or its subcontractor.
- Commodities must be distributed prior to expiration date.

#### 1.14 Freight Charges

COMMODITY is shipped prepaid, product and freight. However, PDA may elect to request and pay for additional drops on inbound shipments, in which case DISTRIBUTOR shall cooperate with PDA in making suitable arrangements with shippers and/or other receivers.

DISTRIBUTOR may pick up inbound shipments or pay inbound shipping charges and have USDA reimburse at a rate determined by USDA. However, arrangements must be made by DISTRIBUTOR directly with USDA.

#### 1.15 COMMODITY Allocations

PDA will execute allocations of COMMODITY within three (3) days of notification of receipt from DISTRIBUTOR. Allocations, showing quantities of each COMMODITY allocated, by RA, will be forwarded by PDA to DISTRIBUTOR, usually through email.

# Note: When DISTRIBUTOR fails to provide PDA with the notification of receipt, the process of allocation and the notification to RAs will be unnecessarily delayed; therefore, DISTRIBUTOR is encouraged to ensure that its internal processes are executed efficiently and accurately.

DISTRIBUTOR, upon receipt of allocation from PDA, shall generate for each RA affected, and <u>no less frequently than monthly</u>, a notification showing quantities of each COMMODITY allocated for its use and the allocation expiration date. Each allocation notice shall include all commodity received by the DISTRIBUTOR and allocated by PDA (since the last notification of allocation, which shall have been released no more than thirty (30) days prior. The expiration date shall be sixty (60) days from DISTRIBUTOR's date of notification.

Upon the arrival of fresh COMMODITY, DISTRIBUTOR shall immediately inspect, document the shelf life, and advise PDA so that if a more restrictive ordering timeframe is warranted, RAs may be adequately advised.

#### 1.16 Allocations: Acceptance and Refusals

NSLP and TRADITIONAL RAs shall have fifteen (15) calendar days from the date of DISTRIBUTOR's allocation notification to reject all or part of the allocation. No response by RA shall be considered an acceptance of the full allocation and is subject to storage charges outlined below.

TEFAP RAs shall have fifteen (15) calendar days from the date of DISTRIBUTOR's allocation notification to reject all or part of the allocation. **No response by TEFAP RAs shall be considered an acceptance of the full allocation.** 

DISTRIBUTOR shall notify PDA no less frequently than monthly of allocation refusals by RAs. The disposition of COMMODITY refused in allocation notification will be at the direction of PDA.

#### 1.17 Minimum Orders and Frequency of Deliveries

A. NSLP RAs:

#### В.

1. Weekly or Bi-weekly Deliveries:

A 30 case minimum order per drop site shall apply to NSLP RAs desiring weekly or biweekly deliveries; however, DISTRIBUTOR may waive the minimum requirement. DISTRIBUTOR must deliver (or issue) weekly to NSLP RAs, provided the 30 case minimum order of COMMODITY is met; however, NSLP RAs may order less than the minimum order at any time by paying the 30 case charge.

2. Monthly Deliveries:

A 15 case minimum order shall apply to NSLP RAs desiring monthly delivery to a single drop site; orders of 14 cases or less may be, at the discretion of DISTRIBUTOR, delivered to designated host sites for (later) pick up by the RA. Host sites must be approved in advance by PDA and should be sites receiving COMMODITY or commercial product from DISTRIBUTOR. Arrangements for pick-ups at host sites must be made by RAs.

NSLP RAs desiring monthly deliveries to multiple drop sites must meet a 15 case minimum at each site.

3. Bi-Monthly Deliveries:

No minimum shall apply to NSLP RAs not meeting the requirement for monthly deliveries or for NSLP RAs, which meet the monthly requirements but agree to allow the DISTRIBUTOR to schedule deliveries less frequently. PDA will assist DISTRIBUTOR in negotiating less frequent deliveries; however, less frequent deliveries may not result in excess storage fees for any COMMODITY remaining in storage more than 60 days from the (original) allocation notice.

- C. TRADITIONAL and TEFAP RAs:
  - 1. Monthly Deliveries:

A 75 case minimum order per drop site shall apply to TRADITIONAL and TEFAP RAs for deliveries within thirty (30) days of DISTRIBUTOR's allocation notice, unless DISTRIBUTOR waives the minimum.

2. Bi-Monthly Deliveries:

A 30 case minimum order per drop site shall apply to TRADITIONAL and TEFAP RAs for deliveries between thirty-one (31) and sixty (60) days from the date of DISTRIBUTOR's allocation notice.

3. Quarterly Deliveries:

No minimum shall apply to TRADITIONAL and TEFAP RAs for deliveries beyond sixty (60) days but within ninety (90) days from the date of the DISTRIBUTOR's allocation notice.

When PDA reallocates any COMMODITY to a TRADITIONAL RA for the purposes of cleaning out residual volumes of COMMODITY previously allocated to another RA, or for the prevention of loss (i.e. for fresh produce) the minimum deliveries shall not apply.

No minimum order shall apply to any RAs picking up orders.

When a TRADITIONAL RA, or a NSLP RA entitled to a Planned Assistance Level (PAL) of \$2,500 or more, as calculated annually by PDA, orders for delivery or pick up, an allocated COMMODITY, and the order would leave in the RA's account a balance of five (5) cases or less of any one item, the RA is required to accept the full balance of the item. For example: an RA, with a PAL of more than \$2,500 having 13 cases of a COMMODITY available, but desiring to order (only) 8 cases, is required to take all 13 cases of the COMMODITY. The RA could order 7 cases and leave a balance of 6, but it cannot leave a balance of 5 cases or less for any one item. The DISTRIBUTOR assumes the responsibility of advising RA's when an order will result for five (5) cases or less of any commodity item.

#### 1.18 Days and Times of Deliveries

Orders delivered or picked up shall be on a scheduled day of the week (or month) established by DISTRIBUTOR. DISTRIBUTOR shall notify RAs of scheduled days of delivery or pick up. <u>RAs must be advised of changes in delivery days thirty (30) days in advance unless waived by RAs</u>.

Delivery for all COMMODITY shall be made between the hours of <u>6:45 a.m. and 2:30 p.m.</u>, unless alternative time schedules are agreed to by RAs and DISTRIBUTOR. DISTRIBUTOR shall strictly adhere to delivery timeframes.

The quality of service provided to RAs by DISTRIBUTOR, including frequency of delivery, shall not be affected by volumes of commercial purchases by RAs. RAs are not required to purchase commercial product from DISTRIBUTOR to receive service under this Agreement.

#### 1.19 Holiday Schedules

DISTRIBUTOR shall notify RAs and PDA of its holiday delivery schedules no less than sixty (60) days in advance.

#### 1.20 COMMODITY Ordering Procedures for RAs

DISTRIBUTOR shall advise RAs on procedures for accessing COMMODITY. Procedures shall include necessary information for RAs to order COMMODITY. DISTRIBUTOR is encouraged to provide for the facsimile transmission of orders or the placement of orders online or through email. Order forms must have DISTRIBUTOR's item numbers, issue site numbers, and "Bill to" numbers. RAs must follow DISTRIBUTOR's ordering procedures and place COMMODITY orders no less than two (2) working days in advance of scheduled day of delivery.

DISTRIBUTOR is encouraged to establish a toll free telephone number for RAs to place COMMODITY orders or to inquire about program matters.

#### 1.21 Outbound Deliveries

DISTRIBUTOR may deliver COMMODITY in straight vans containing COMMODITY only, or in vans with other food commercially supplied, as long as the storage temperature is maintained and as long as other terms of the contract are satisfied. COMMODITY may not be stored or delivered with any chemical, which may diminish quality or safety.

#### 1.22 Delivery Sites

DISTRIBUTOR must secure from RAs decisions on how COMMODITY will be accessed. RAs may have COMMODITY delivered to self-operated warehouses, licensed food preparation sites, host sites, or picked up at DISTRIBUTOR's warehouse. Decisions by RAs cannot change without sixty (60) days advance notice to DISTRIBUTOR unless DISTRIBUTOR grants a waiver. PDA reserves the right to deny a delivery to any RA designated site.

#### 1.23 Delivery Drop Areas

COMMODITY shall be delivered to delivery drop areas. Delivery drop areas at food preparation sites located on the entry level of building are inside the door or a walk-in dry grocery area, freezer, or cooler. When the grocery area, freezer, or cooler is located on a level above or below the entry level of the building, delivery shall be inside a portal of the entry level of the building. Deliveries of COMMODITY to levels above or below the entry level of the building are at the option of DISTRIBUTOR.

Drivers and helpers shall <u>not</u> be required to stow COMMODITY on shelves nor stack in reach-in coolers, freezers, or other cabinets, or to rotate stock.

Delivery drop areas at an RA's warehouse are across receiving platforms. Where no receiving platform or reasonable portal entry exists delivery of COMMODITY will be at the tailgate of the delivery vehicle.

COMMODITY picked-up from DISTRIBUTOR's facility shall be at platform out loading doors or slots.

PDA shall have sole authority to: 1) resolve disputes between RAs and DISTRIBUTOR involving the identification of delivery drop areas; and, 2) determine if delivery drop areas provide reasonable access. In resolving disputes, PDA shall consider standard practices of the food distribution industry and the unique nature of RAs and RA facilities.

Drivers and helpers shall require an authorized receiver to verify accuracy of each shipment, including quantities of each item, total quantities, and condition of COMMODITY. Each delivery ticket must be receipted (signed) by the RA. Variations from the norm, e.g., shortages or damages, shall be noted on each ticket by RA, and initialed by the truck driver and RA.

#### 1.24 Special Deliveries

Special or intermediate deliveries shall be required if DISTRIBUTOR fails to deliver COMMODITY in stock and properly ordered by an RA. When such an error is made, DISTRIBUTOR shall make delivery without additional charge the <u>following workday</u>, unless RA agrees to a later delivery date.

#### 1.25 Product Transfer

PDA may require DISTRIBUTOR to transfer COMMODITY to facilities of another entity. When requested by PDA, DISTRIBUTOR shall execute transfers within two (2) weeks and make transfers on exchangeable pallets. Transfers may be full or partial truckload lots and contain more than one COMMODITY. PDA may have DISTRIBUTORs pick up COMMODITY from other warehouses. PDA will pay for transfers of COMMODITY (delivered or picked up) at the lowest rate of the DISTRIBUTOR in effect at the time of the transfers.

#### 1.26 Transition Responsibility

DISTRIBUTOR agrees to pick up and store at no cost to PDA and for a period of thirty (30) days prior to the effective date of the Agreement, a maximum of 10,000 cases of COMMODITY from the distributor currently under Agreement with PDA and serving the ADR impacted by the DISTRIBUTOR's bid.

#### 1.27 Distribution FEEs

Distribution FEEs that a DISTRIBUTOR may charge for delivery or pick up of COMMODITY are limited to the FEEs submitted in response to the IFB as accepted by PDA, and as adjusted under the IFB, and shall apply to dry, chilled, and frozen COMMODITY.

Distribution FEEs submitted in response to the IFB shall be on a per case basis and shall be all inclusive; no other charges shall be assessed, except as provided for in the IFB. DISTRIBUTOR shall include on its Bid Sheet, for each ADR for which a bid is submitted, a FEE for each category of RA listed (see Bid Award Criteria in Section 1.48).

When COMMODITY received from USDA has a net case weight of 15 pounds or less, as defined by USDA on the item's specification document, PDA at its sole discretion, may require DISTRIBUTOR to ship two (2) cases for the distribution FEE of one (1) case. For example, if the DISTRIBUTORS distribution FEE was \$1.50 per case, PDA may require DISTRIBUTOR to deliver two (2) cases of a commodity with a case weight of 10 pounds, for one fee of \$1.50. When DISTRIBUTOR ships two (2) cases for the distribution FEE of one (1) case instead of two (2); or fifteen (15) instead of thirty (30).

#### 1.28 Distribution FEE Adjustments

Distribution FEEs submitted by DISTRIBUTOR on its Bid Sheet and accepted by PDA shall remain firm for the first twelve months of the Agreement.

FEEs will be adjusted by PDA on the first day of each new program year (beginning July 1, 2022) within the following parameters:

A. FEE adjustments for program years beginning July 1 will be calculated on previous year's annual FEE without regard to fuel surcharges. The average (self-service diesel fuel) price for the 12-month period ending March 31 will be compared to the average price for the same 12-month period- one year earlier. For each full \$0.08 increase per gallon, the fee per case for delivery of USDA food will be increased by \$0.01. The adjustment will become effective July 1 of the following year for the remainder of the contract. PDA will use the average increase reported by the U.S. Bureau of Labor & Statistics in Series ID: API000074717, Series Title: "Automotive diesel fuel, per gallon/3.785 liters in U.S. city average, average price not seasonally adjusted"; and be limited to no more than 6% each year; and shall be net any per case adjustment allowed by PDA under 1.29 B. regarding Fuel Surcharge (see below). For example, if the annual adjustment results in a \$0.28 per case increase, the distributor per case fee will be increased by \$0.03. The total increase cannot exceed 6% each year and is contingent upon the availability of funds.

#### 1.29 Exceptions to FEE Adjustments

A. Waiver of 6% Maximum

PDA, at its sole discretion, may waive the annual maximum FEE adjustment of six percent (6%) if it determines that specific costs incurred by DISTRIBUTORs are not appropriately reflected in the annual FEE adjustment.

B. Fuel Surcharge

If PDA determines that application of Section 1.28 penalizes DISTRIBUTOR because of extraordinary fuel price increases and that application of Section 1.29A, would penalize PDA and RAs, PDA may, at its sole discretion, authorize a per case fuel surcharge for a period of time and for a specific per case amount to be determined solely by PDA. PDA will use as guidance indices available from the American Automobile Association (AAA) and the Oil Price Information Service (OPIS) and the indices used in Section 1.28 to determine a fair and reasonable surcharge. PDA may rescind the fuel surcharge by giving thirty (30) days notice to Distributor, when PDA determines the surcharge is no longer warranted.

#### 1.30 Storage FEEs

RAs have sixty (60) days of free storage of COMMODITY allocated and remaining in the RA's account. The sixty (60) days is calculated from the date of DISTRIBUTOR's notification to the RAs that the COMMODITY has arrived and is available for order by RA.

COMMODITY remaining in the account of an RA is subject to a storage FEE of \$.50 per case for each thirty (30) day period, or partial period thereof, beginning on day 61 and continuing through day 120. Beginning on day 121, COMMODITY remaining in the account of an RA is subject to a storage FEE of \$1.00 per case for each thirty (30) day period, or partial period thereof.

The DISTRIBUTOR must notify PDA of containing COMMODITY remaining in an RA's account after five (5) months from the date of the DISTRIBUTOR's allocation notification to the RA at its discretion after 5 months PDA may list such items on a refusal list for other RA's to access.

When PDA determines that DISTRIBUTOR's notification to RAs for COMMODITY was not actually mailed or made available to RAs on the printed date or within three (3) days thereof, the DISTRIBUTOR must ensure that the sixty (60) days or thirty (30) days free storage is not diminished.

#### 1.31 Payment of Distribution and Storage FEEs

- A. NSLP and TRADITIONAL RAS
  - Payment of distribution FEEs, pick-up FEEs and storage FEEs for COMMODITY allocated to and delivered to or picked up by NSLP or TRADITIONAL RAs shall be made by affected RAs. <u>DISTRIBUTOR shall</u> invoice each RA directly for the appropriate FEEs.

When an RA is sixty (60) days late in its payments for services provided by DISTRIBUTOR, DISTRIBUTOR may suspend services with proper notification to RA and PDA. PDA will assist DISTRIBUTOR in securing settlement of delinquent accounts; however, PDA shall not be liable for any unpaid invoices of any NSLP or TRADITIONAL RA as a result of the IFB.

#### B. TEFAP RAs

Payment of distribution FEEs for COMMODITY identified by PDA as COMMODITY received under The Emergency Food Assistance Program (TEFAP) for delivery to TEFAP RAs (as defined by PDA) shall be made by PDA. The affected COMMODITY will be identified by PDA and be tracked on inventory and activity reports.

Payment of distribution FEES by PDA for TEFAP COMMODITY shall be payable upon the submission by DISTRIBUTOR of a monthly invoice to PDA. This invoice should include only one month's worth of receipts clearly identified by material code and commodity name. These can be submitted to the designated person at PDA by email. The invoice should be signed prior to scanning and emailing.

COMMODITY allocated by PDA to TEFAP RAs, and delivered or released by DISTRIBUTOR to TEFAP RAs shall be invoiced to PDA separately.

When DISTRIBUTOR serves more than one ADR, for which DISTRIBUTOR is entitled to different FEEs, distribution FEEs shall be prorated by ADR based on a percentage established by PDA, and adjusted periodically by PDA.

#### Note: PDA will not require DISTRIBUTOR to submit a separate invoice for the payment of such FEEs; therefore, it is incumbent upon DISTRIBUTOR to ensure that properly signed receiving documents for each COMMODITY are forwarded immediately to PDA. The properly executed receiving document shall be considered by PDA as the document authorizing payment.

Payment of FEEs by PDA when TEFAP COMMODITY is received and its receipt properly documented shall not diminish DISTRIBUTOR's responsibility for the proper storage, handling, and accounting for each case of COMMODITY; nor change any other responsibility of DISTRIBUTOR under the IFB.

When PDA has made payment to DISTRIBUTOR as outlined above, and subsequently any quantity of the affected TEFAP COMMODITY is later allocated by PDA to an NSLP RA or a TRADTIONAL RA, and those agencies pay the attendant FEEs, DISTRIBUTOR shall ensure that PDA is properly credited. For example, if PDA had paid DISTRIBUTOR the proper FEEs for 1,000 cases of TEFAP COMMODITY, and later, 100 cases of the TEFAP COMMODITY are allocated to and received by a TRADITIONAL RA, for which the TRADITIONAL RA pays DISTRIBUTOR its per case delivery or pick-up FEE, DISTRIBUTOR shall credit PDA for the full amount associated with the 100 cases.

When PDA allocates to TEFAP RAs COMMODITY not designated as a TEFAP item (for which payment has not been made by PDA) DISTRIBUTOR shall separately invoice PDA for the quantities delivered to TEFAP RAS.

Storage FEEs for TEFAP RAs shall be calculated using a FIFO inventory rotation on each COMMODITY.

Invoices submitted to PDA for payment for storage FEEs must clearly identify the lot number and receipt date for items being invoiced. In effect, storage fees for TEFAP commodity shall be calculated by item and not by allocations to TEFAP RAS.

DISTRIBUTOR shall not send to any TEFAP RA or disclose on delivery tickets, etc. any delivery fee or storage fee or anything that will suggest to the TEFAP RA that they are responsible for payment. It shall be clear that the fees are paid by PDA.

PDA may require DISTRIBUTOR to bill PDA for delivery FEEs for COMMODITY delivered or issued to any RA; and for storage FEEs for specifically identified COMMODITY.

Unless otherwise specified above, invoices submitted to PDA for services provided by DISTRIBUTOR shall include a summary of issue tickets for each delivery site. Referenced tickets shall be listed in numerical sequence and show the total number of cases, bags, etc. issued or delivered.

#### 1.32 Premium Storage FEEs

When PDA determines that shipments of any specific COMMODITY from USDA have been excessive in any calendar month, and that because of those excessive shipments, the volume of the identified COMMODITY has resulted in an unusually high level of inventory of the identified COMMODITY, PDA may, at its sole discretion, authorize payment to DISTRIBUTOR a premium storage fee of \$.50 per case per month or partial month thereof, for the quantity of the identified COMMODITY determined by PDA to be excessive. The premium storage fee shall be payable by PDA <u>only</u>; not by any RA. The time period for which the premium storage fee is payable shall be determined solely by PDA.

#### 1.33 Minimum Invoice for Storage FEEs

An invoice generated by DISTRIBUTOR for PDA or any RA for storage fees under this IFB shall be for an amount no less than \$5. For example, an invoice for storage fees for five (5) cases of product at \$.50 per case for a one (1) month period would total \$2.50; however, by application of the Minimum Invoice Fee, the invoice would be for \$5. The minimum does not apply to delivery or pick-up FEEs.

#### **1.34** Warehouse and Delivery Equipment Requirements

Facilities used to service the RAs must be either located within the Commonwealth of Pennsylvania or within 50 miles of the Pennsylvania state line.

DISTRIBUTOR must have facilities adequate to service in each ADR bid volumes of COMMODITY outlined in the IFB, including surges in volume; and must have trucks to deliver predicted volumes of frozen, chilled, and dry food. PDA may examine prior to the execution of an Agreement, facilities of vendors submitting bids to ensure vendor qualification.

DISTRIBUTOR must have adequate facilities to store:

- Dry COMMODITY in an area with forced ventilation and temperatures between 50 degrees and 70 degrees Fahrenheit;
- Frozen COMMODITY at temperatures 0 degrees Fahrenheit or below; and,
- Chilled COMMODITY at temperatures between 32 degrees and 48 degrees Fahrenheit, depending on the item.

DISTRIBUTOR shall separate by warehouse slot COMMODITY from commercial product and other USDA product received by DISTRIBUTOR under separate contracts, unless waived in advance by PDA.

DISTRIBUTOR must have for COMMODITY, storage capacity to accommodate pallets in bulk, or in or on top of racks at the rate of 20 pallets per 1,000 cases of COMMODITY during peak inventory periods. Peak inventory is estimated at 25% of annual volumes listed on Attachment "B" and usually occurs between November and February. DISTRIBUTOR must have sufficient capacity to handle volumes listed or have adequate contingency plans to handle the volumes.

DISTRIBUTOR must have available adequate delivery vehicles as follows:

- Separate van trucks for dry COMMODITY and refrigerated trucks for integrated loads of dry and refrigerated COMMODITY.
- Dual compartment trucks for combined handling of dry and frozen COMMODITY; or
- Single compartment refrigerated trucks (0 degrees F) for separate or integrated loads of dry and refrigerated COMMODITY.

The number of vehicles required depends on size of trucks, the number of delivery routes and the extent to which deliveries of COMMODITY are integrated with deliveries of commercial food.

#### 1.35 Sanitation Requirements

The USDA, PDA, or their designees may, at any time, inspect DISTRIBUTOR's, or its subcontractors' facilities and delivery vehicles for sanitation and temperature maintenance. Facilities, delivery vehicles, warehousing and delivery practices must be in compliance with the governing state and federal laws and regulations, and USDA-FNS Manual V, <u>Guidelines for the Storage and Care of Food Products.</u>

DISTRIBUTOR may be inspected by the Bureau of Food Safety and Laboratory Services, Pennsylvania Department of Agriculture. Cited deficiencies must be corrected within thirty (30) days of the citation.

#### 1.36 Liaison with PDA

DISTRIBUTOR shall maintain liaison with PDA on matters relating to:

- Inventory levels;
- Schedules of inbound shipments;
- Notices of shipment arrival; and,
- Monthly activity and inventory reports.

#### 1.37 Computer Capability

DISTRIBUTOR must have adequate computer capability to:

- Update RA list as directed by PDA;
- Accurately produce and <u>timely</u> deliver and/or electronically transmit required reports;
- Track residual quantities of COMMODITY available to RAs, by each RA's identification number;
- Prevent over ordering, over allocation, and over shipping of COMMODITY
- Complete and file on-line commodity receiving and documents using WBSCM

#### 1.38 Inventory Reports

DISTRIBUTOR shall maintain perpetual inventory records for COMMODITY received and distributed under the IFB, and shall retain records for review by PDA or its designees for a period of three (3) years from the close of each fiscal year (ending June 30).

DISTRIBUTOR must provide PDA no later than ten (10) days after the close of each month, a monthly inventory report (see below) for all through email in an order and format compatible and acceptable to and defined by PDA.

<u>Monthly inventory reports shall be on a calendar basis only, unless waived by PDA</u>. For example, inventory reports reflecting activity for October shall only include data dated from October 1 through October 31. It shall <u>not include any activity dated from any other calendar</u> <u>month</u>. It shall be DISTRIBUTOR's responsibility to identify the format acceptable to PDA's data processing unit.

Inventory Reports shall show by COMMODITY, in total and by RA, quantities (number of cases) on hand at the beginning of the month; quantities received during the month; quantities distributed during the month; quantities removed from book inventory as a result of damage; and quantities on hand at the end of the month.

Receipts of COMMODITY on monthly inventory reports shall include only the case volume for which the DISTRIBUTOR signed on the day received from USDA as an inbound shipment. The DISTRIBUTOR shall ensure that reallocations of COMMODITY are not reported on inventory reports as new receipts.

DISTRIBUTOR shall provide PDA upon request printed monthly Inventory Reports at the close of each <u>calendar</u> month.

DISTRIBUTOR must provide PDA no less frequently than monthly, refusals of commodity allocations, or commodities store in excess of 5 months, by item, by RA, for PDA to reallocate to other RAs. This function ensures an improved turnover rate for COMMODITY.

Transfers of COMMODITY authorized by PDA to or from other facilities under contract with PDA must be tracked separately from receipts (from USDA shipper) and disbursements (to RAs). Transfers of COMMODITY <u>shall not</u> be reported on inventory reports as new receipts, but as "Transfers In" or "Transfers Out" only. DISTRIBUTOR is responsible for correcting in subsequent reports, any data filed incorrectly in previous reports.

DISTRIBUTOR shall provide PDA upon request by program year an ending inventory report showing, by COMMODITY: beginning inventory; receipts; disbursements; and ending inventory.

DISTRIBUTOR shall conduct a physical inventory count of COMMODITY during the last week of each program year, or as directed by PDA, and provide the results to PDA within thirty (30) days. However, PDA staff will usually conduct year-end physical inventory counts. When PDA conducts physical inventory counts DISTRIBUTOR must cooperate fully and provide no less than two staff members to assist. DISTRIBUTOR must also adjust June 30 inventory balances to physical counts before sending to PDA its June report.

#### 1.39 Activity Reports

DISTRIBUTOR shall provide PDA upon request printed individual activity reports for each RA served, showing by COMMODITY, quantities offered and delivered per month and annually. Activity reports must be in sequence, based on RA identification number as assigned by PDA. No page shall contain data on more than one RA.

DISTRIBUTOR shall provide PDA upon request by RA and by COMMODITY, quantities of COMMODITY stored and length of storage.

Consolidated Activity Reports and Inventory Reports may be submitted if authorized by PDA and all required data are included.

#### 1.40 Record Retention, Reviews and Audits

DISTRIBUTOR shall maintain records fully accounting for receipt and disposition of all COMMODITY. Records must be retained for three (3) years following the close of the fiscal year to which they pertain or three (3) years following the date of the last payment made by the PDA, whichever is later; and be available for review by USDA, PDA, PDA's designee, and the Auditor General of Pennsylvania.

For audit purposes DISTRIBUTOR must maintain an audit trail between computer printouts and delivery tickets. Delivery tickets must be organized numerically or chronologically and easily accessed. Delivery tickets may be audited in total or in part at DISTRIBUTOR's warehouse or DISTRIBUTOR may be required to send delivery tickets to PDA.

#### 1.41 Liaison with Recipient Agencies (RAs)

DISTRIBUTOR shall maintain liaison with RAs and is encouraged to maintain a toll free telephone number for communications from RAs. DISTRIBUTOR is also encouraged to provide for the placement of orders and the viewing of inventory balances on-hand through the Internet. DISTRIBUTOR's procedures for maintaining its liaison with RAs must be approved by PDA.

DISTRIBUTOR shall also:

- Track utilization of each COMMODITY by RA.
- Clearly identify and advise RAs of "Out of Stock" items.
- No less than monthly provide to RAs by COMMODITY: 1) a listing of all allocations to date; 2) quantities shipped to date; and 3) balances remaining in the RA's account. Formats must be clear and concise.

Note: DISTRIBUTOR is cautioned that inventory turns for COMMODITY is highly dependent on the DISTRIBUTOR's effectiveness in informing RAs of cases of product allocated, pulled, and remaining in storage at the DISTRIBUTOR's facility. DISTRIBUTORs are encouraged to develop and maintain an efficient and effective line of communication for advising RAs of the availability of COMMODITY.

#### 1.42 Receiving Reports

DISTRIBUTOR shall forward to PDA upon receipt and verification of shipments, documents related to COMMODITY, including Bills of Lading.

#### 1.43 Accountability

DISTRIBUTOR shall be financially responsible for all COMMODITY received and shall assume and bear the risk of all loss, damage or theft or improper use of COMMODITY while in the possession or control of DISTRIBUTOR.

DISTRIBUTOR must carry insurance on COMMODITY received, be responsible for shortages and damages, and submit any report requested by PDA.

(1) In accordance with the federal regulatory provisions at 7 CFR § 250.12(f)(1), the Distributor agrees it will store, manage, and transport USDA Foods in a manner that properly safeguards them against theft, spoilage, damage, or other loss, in accordance with the following requirements:

(a) *Safe storage and control.* The Distributor must provide facilities for the storage and control of USDA Foods that protect against theft, spoilage, damage, or other loss. Accordingly, such storage facilities must maintain USDA Foods in sanitary conditions, at the proper temperature and humidity, and with adequate air circulation.

(b) *Inventory management.* The Distributor must ensure USDA Foods are stored in a manner that permits them to be distinguished from other foods, and must ensure that a separate inventory record of USDA Foods is maintained.

- (2) In accordance with the federal regulatory provisions at 7 CFR § 250.12(f)(2), the Distributor agrees it will comply with all Federal, State, or local requirements relative to food safety and health, including required health inspections, and procedures for responding to a food recall.
- (3) In accordance with the federal regulatory provisions at 7 CFR § 250.12(f)(7), the Distributor acknowledges that they will only be eligible for contract extension or renewal upon fulfillment of all current contract provisions.
- (4) In accordance with the federal regulatory provisions at 2 CFR § 200, Appendix II(A), the Distributor acknowledges that in the event of a breach or violation of the contract terms the Distributor may be subject to administrative sanctions and/or any contractual or legal remedies available to PDA, as the circumstances of the breach or violation warrant.
- (5) The Distributor agrees to adhere to all applicable requirements listed under OMB Uniform Guidance at 2 CFR § 200, Appendix II.

#### 1.44 Insurance

DISTRIBUTOR must purchase and maintain at its expense the following types of insurance, issued by a company authorized to do business in Pennsylvania and acceptable to PDA, and shall provide a Certificate of Insurance to PDA upon execution of the Agreement and each anniversary date thereof:

A. "All Risk" escalating warehouse contents insurance with coverage equal to the total value of COMMODITY in its possession at any one time.

B. Comprehensive General Liability Insurance. The limits of such insurance shall be not less than \$1,000,000 for injury to or death of one person in a single occurrence and \$3,000,000 for injury to or death of more than one person in a single occurrence and \$500,000 for a single occurrence of property damage.

#### 1.45 Shortages and Damages

DISTRIBUTOR shall be financially responsible for shortages and damages to COMMODITY as well out of date COMMODITIES, which make them unacceptable to PDA. Damages shall include infestation due to improper storage conditions, as well as physical damages to containers, including serious rust.

DISTRIBUTOR shall reconcile overages or shortages between physical inventory and book inventory annually. Overages and shortages not explained to the satisfaction of PDA will be netted, using applicable values of COMMODITY as established by PDA or USDA.

If the value of shortages exceeds the value of overages, a monetary or in-kind settlement for the differences in value will be required. If the value of overages exceeds the value of shortages, no settlement is required. Book inventory will be adjusted after settlement to correspond with physical inventory count. Adjustments for overages and shortages, and inventory shrinkage may be allowed in compliance with USDA regulations.

#### 1.46 Self-Service Agencies

PDA reserves the right to direct ship COMMODITY to large recipient agencies or their representatives.

#### 1.47 Instructions for Completing Bid Sheets

DISTRIBUTOR should study data and performance requirements of the IFB and complete the Bid Sheet(s). Bid Sheets will be declared void and vendor unresponsive if both "delivery" FEE per case and "pick up" FEE per case are not included.

#### 1.48 Bid Award Criteria

For ADRs I, II, III, IV, V, VI, VII, DISTRIBUTOR will be selected on the following criteria:

- A. The lowest weighted average "delivery" FEE per case submitted on the Bid Sheet, with 52% weight given to the delivery FEE for NSLP RAs and 48% weight to the delivery FEE for TRADITIONAL and TEFAP RAs. The "pickup" FEE per case must be included on the Bid Sheet; however, only the weighted average "delivery" FEE per case will be used to determine lowest bid.
- B. Compliance with all documentation and information required in the specifications in the IFB. Failure to include required documentation and information may result in the rejection of the bid as non-responsive.
- C. Adequacy of facilities, services, and other relevant qualifications as evaluated by PDA. PDA's evaluation may include an on site inspection at the bidder's facility and subcontracted facilities, if any. After PDA's evaluation, bids submitted by vendors whom PDA determines not to be qualified or responsible vendors shall be rejected. PDA's determination shall be final. (See Bid Sheet example.)

For ADR VIII (only), DISTRIBUTOR will be selected on the following criteria: A. The low weighted average per case "delivery" FEE, calculated by:

- 1. Combining the "per case delivery FEE" for NSLP RAs, except Philadelphia School District, weighted at 52%, with the "per case pick up FEE" for Philadelphia School District, weighted at 48%, with the total weighted additionally at 52%, combined with:
- The "per case delivery FEE" for TRADITIONAL and TEFAP RAs outside of Philadelphia, weighted at 30%; added to the "per case delivery FEE" for TRADITIONAL and TEFAP RAs within Philadelphia, weighted at 70%, with the total additionally weighted at 48%. (See Bid Sheet example.)

#### Note: The "pick-up" price per case must be included on Bid Sheet, however, only the weighted average "delivered" price will be used to determine lowest bid.

- B. Compliance with all documentation and information required in the specifications in the IFB. Failure to include required documentation and information may result in the rejection of the bid as non-responsive.
- C. Adequacy of facilities, services, and other relevant qualifications as evaluated by PDA. PDA's evaluation may include an on site inspection at the bidder's facility and subcontracted facilities, if any. After PDA's evaluation, bids submitted by vendors whom PDA determines not to be qualified or responsible vendors shall be rejected. PDA's determination shall be final. (See Bid Sheet example.)

PDA reserves the right to reject any or all bids and to waive technical defects or any informality in bid.

#### 1.49 Bid Submission

Bids to provide services under this IFB must be submitted electronically through the SRM Vendor Portal. Attachment E also needs completed and uploaded as an attachment to your bid submission. The due date for this solicitation will be February 26, 2021 at 2:00 PM. In lieu of a pre-proposal conference all potential offerors have the opportunity to submit questions via email Sheila Strubhar at sstrubhar@pa.gov. The deadline to receive questions is close of business February 11, 2020. Answers to all submitted questions will be posted to emarketplace and SRM no later than close business February 16, 2020. The Q&A document will become an official part of the IFB document.

#### 1.50 Financial Requirements

DISTRIBUTORs submitting successful bids must provide PDA upon request evidence of adequate financial resources to sustain operations for the period of the Agreement. Evidence shall be in the form of audited financial statements, including Independent Auditors Opinion performed, at the bidder's expense by a Certified Public Accountant.

#### 1.51 Performance Bond

Prior to the execution of an Agreement, DISTRIBUTOR submitting a successful bid must secure and submit to PDA by June 1, 2021, a Performance Bond in the amount of \$25,000. The Performance Bond must remain in effect for the term of the Agreement.

Evidence of proper and continuing Bond coverage may be requested by PDA at any time but must be provided to PDA annually on June 1 of each calendar year. Failure to obtain Bond coverage by June 1, 2021 or failure to maintain proper coverage will result in cancellation of the Agreement.

Performance bonds shall be obtained through any surety company licensed to do business in Pennsylvania and approved by PDA. Letters of Credit or other security instruments may be accepted in lieu of Performance Bonds, but only with prior approval of PDA.

#### 1.52 Requirement of Successful Bidders

DISTRIBUTORs submitting successful bids to provide services under the IFB must provide PDA by June 1, 2021, and thereafter as any changes occur, the name and phone number of one (1) staff person who shall be PDA's sole contact for all matters relating to the IFB. The staff person so identified shall have the responsibility to investigate all questions and problems arising under the IFB and report back to PDA within three (3) working days with answers to questions and resolutions of problems identified by PDA.

#### Section II: General Bid Conditions

#### 2.01 Licenses and Certificates

DISTRIBUTOR may be required by the Pennsylvania Public Utility Commission (PUC) statutes to have a license to deliver COMMODITY under the IFB. Responsibility for acquiring and paying for any license required, prior to contract award, rest solely with DISTRIBUTOR.

DISTRIBUTOR must be registered with the Bureau of Food Safety and Laboratory Services, Pennsylvania Department of Agriculture.

If DISTRIBUTOR is a corporation, it must be incorporated in Pennsylvania or have a certificate of authority to conduct business in Pennsylvania. Reference to the corporate box number and a list of the officers of the corporation shall be provided upon request of PDA.

DISTRIBUTOR must maintain and provide PDA upon request evidence of membership in a public warehousing association or distributor association dedicated to the development and maintenance of high performance standards for members.

#### 2.02 Prime Contractor Responsibilities

DISTRIBUTOR assumes full responsibility for all services required by the IFB whether or not provided by DISTRIBUTOR or an approved subcontractor. In addition, PDA will consider DISTRIBUTOR to be the sole point of contact with regard to contract matters.

DISTRIBUTOR shall provide PDA upon request, a contingency plan for storage of COMMODITY should warehouse capacity be exceeded due to expansion of the program or the expansion of DISTRIBUTOR's commercial accounts at its primary storage facility(ies).

DISTRIBUTOR must report its intent to subcontract for facilities and services under the IFB to PDA for PDA approval in advance. DISTRIBUTOR will be held responsible for subcontractor performance. DISTRIBUTOR shall provide one-stop pick up of orders by all RAs. Orders of COMMODITY, regardless of storage location, must be assembled at DISTRIBUTOR's primary facility for pick up unless waived by RA.

#### 2.03 Other Requirements

DISTRIBUTOR must provide PDA upon request:

- References from three current customers with at least one being a Pennsylvania based company. The references must include names and addresses of customers and names and telephone numbers of representatives of customers who can be contacted.
- A duly notarized self-declaratory statement of net worth (total assets minus total liabilities). The statement may be subject to verification by PDA if deemed necessary.

DISTRIBUTOR agrees to indemnify and hold the Commonwealth, PDA, their officers, agents, and employees harmless from and against any and all suits and judgments for damages for personal injury, death, or damage to real or tangible personal property arising out of or in conjunction with services provided by DISTRIBUTOR under Agreement and caused by DISTRIBUTOR's negligence or intentional wrongful acts.

DISTRIBUTOR will perform services required under the Agreement as an independent contractor and not as an agent of PDA.

#### 2.04 Agreement Period

The effective date of the Agreement shall be fixed by PDA after the Agreement has been fully executed by the DISTRIBUTOR and the Commonwealth (but will not begin prior to July 1, 2011); all approvals required by Commonwealth contracting procedures have been obtained; and the Agreement has been returned to the DISTRIBUTOR. The end date is June 30, 2026.

#### 2.05 Agreement Termination

PDA may terminate the Agreement for cause upon thirty (30) days written notice to DISTRIBUTOR; however, PDA may require DISTRIBUTOR to perform all services attendant to the IFB for period not to exceed six (6) months from the date of the notice. PDA may also terminate the Agreement without cause or due to the non-availability of funds upon sixty (60) days written notice and require DISTRIBUTOR to perform all services attendant to the IFB for period not to exceed six (6) months from the date of the notice. DISTRIBUTOR shall be entitled to applicable fees for services provided prior to termination.

DISTRIBUTOR may terminate the Agreement without cause. However,

if DISTRIBUTOR terminates its Agreement, with or without cause, DISTRIBUTOR must advise PDA in writing no later than February 1<sup>st</sup> of the affected calendar year and PDA shall have until July 31<sup>st</sup> of the same calendar year to exhaust the inventory of COMMODITY that remain at the DISTRIBUTOR's facility. The six (6) month notification period is required by PDA to release for public bid a new IFB and direct inbound shipments of COMMODITY to auxiliary facilities. During the six (6) month period, DISTRIBUTOR may be required by PDA to transfer or deliver residual quantities of COMMODITY to warehouses designated by PDA or to RAs at established prices per case. Payments for transfers to warehouses will be made by PDA. Payments for deliveries to RAs will be as outlined in this IFB.

If DISTRIBUTOR terminates the Agreement without cause, DISTRIBUTOR will be ineligible to bid on subsequent COMMODITY distribution IFBs issued by PDA for a period of five (5) years.

#### 2.06 Incurred Costs

PDA is not liable for any cost incurred by DISTRIBUTOR prior to execution of IFB Agreement, except as outlined above.

#### 2.08 Addenda to IFB

If it becomes necessary to revise any part of this IFB, addenda will be provided to all vendors who receive the initial IFB.

#### 2.09 Bid Duration

All bids submitted under the IFB will be firm for 120 calendar days. If a bidder submitting the lowest bid is determined to be unresponsive or unresponsible, the next lowest responsive and responsible bidder will be offered an Agreement.

#### 2.10 Additional Conditions

- A. DISTRIBUTOR shall be liable for gross receipt taxes in accordance with Pennsylvania statutes.
- B. Prompt payment discounts may be offered but will not be considered in determining low bid.
- C. If DISTRIBUTOR defaults or fails to abide by terms of the Agreement, PDA, after notice in writing, may procure services from other sources and hold DISTRIBUTOR responsible for any excess cost occasioned thereby.
- D. DISTRIBUTOR understands and agrees with the following: "By my signature on this bid, I certify that this bid is made without prior understanding, agreement, or connection with any corporation, firm, or person submitting a bid for the same service, and is in all respects fair and without collusion or fraud. I understand collusion is a violation of law and can result in fines, prison sentences, and civil damage awards I agree to abide by all conditions of this bid and certify that I am authorized to sign for DISTRIBUTOR."
- E. Modification, additions, or changes to the terms and conditions of the IFB may be cause for rejection of any bid.
- F. The Agreement constitutes the entire agreement between the parties. No amendment of modification changing its scope or terms shall have any force or effect unless in writing and signed by both parties.
- G. The Agreement and all other agreements executed pursuant hereto shall be deemed to be contracts, made under the laws of the Commonwealth of Pennsylvania and, for all purposes, shall be construed in accordance with laws of such Commonwealth.
- H. The terms and provisions of the Agreement are severable. In the event of the unenforceability or invalidity of any one or more of the terms, covenants, conditions or provisions of the Agreement under federal, state or other applicable laws, such unenforceability or invalidity shall not render any other terms, covenants, conditions or provisions thereof unenforceable or invalid.


- I. Any forbearance by PDA in exercising any right or remedy hereunder, or otherwise afforded by applicable law shall not be a waiver of or preclude the exercise of any such right or remedy at any appropriate time.
- J. DISTRIBUTOR shall not assign or subcontract the Agreement or any part thereof without the prior written consent of PDA.
- K. DISTRIBUTOR agrees that performance of its obligations under the Agreement will comply with all applicable federal, state and local laws and regulations.

#### 2.12 Single or Multiple Pricing

There will be no multiple pricing factors considered in determining the lowest bid except as outlined in the IFB.
